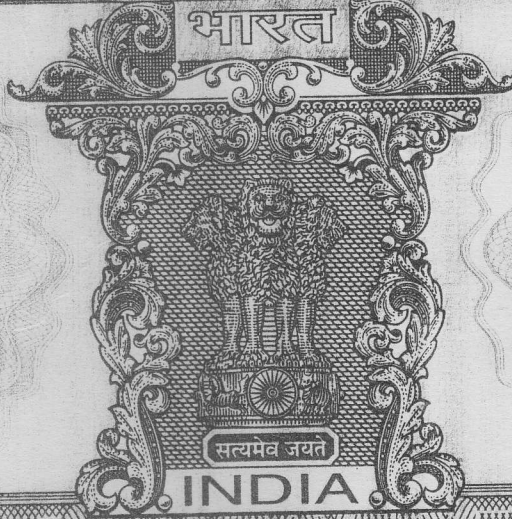

2 nd Party	:	Rs.1,50,000/- p.m.

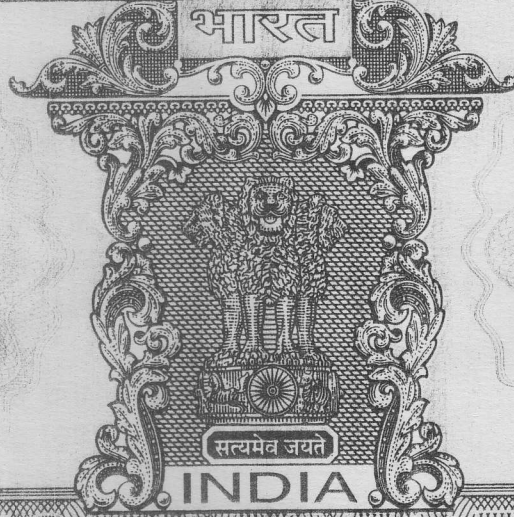
The partners are at liberty to revise their remuneration from time to time by their mutual consent.

The parties hereto hereby mutually agree that Dr. M.R. MORRIS, who was running the hospital hitherto, shall be paid a sum of Rs.70,000/- per month for his advisory role on hospital management, which shall be treated as an expenditure of the firm.

8. The profession of the firm shall be carried on jointly by both the parties hereto and for this purpose both of them shall have all powers of management that are deemed necessary and incidental to the carrying on of the partnership business. However for purpose of convenience the parties hereto hereby mutually agree that the first party hereto shall be designated as "Managing Partner" of the firm and he shall represent the firm before all Government Offices, Courts of Law, Tribunals, Consumer Disputes forums, etc, whenever need arises.

9. Both the partners shall have the power to operate the bank accounts on behalf of the firm and they shall operate such accounts individually on behalf of the firm and the same shall be binding on the other partner.

10. Borrowings for the purpose of the profession of the partnership from banks, or others, either on security or otherwise, shall be made only with written consent of both the parties hereto.


11. None of the parties hereto shall without the consent of the other partner sell, mortgage, assign or otherwise part with his or her share or interest in the partnership profession or knowingly or wilfully act, commit, or permit any act whereby the partnership business is dislocated or disturbed to the detriment of the other partner.

12. The partners shall keep and maintain proper books of accounts and other records as are usually kept in a profession of like nature and each of the parties hereto shall have free access to them and shall be at liberty to inspect or to take copies or extracts therefrom.

13. Both of the partners shall be just and faithful to each other in all their dealings and transactions connected with the profession of the partnership and they shall carry on the same to the greatest common advantage.

14. The Managing Partner shall keep and maintained proper books of accounts and other records and each of the parties hereto shall be at liberty to inspect or to take copies or extracts from the same.

15. The annual accounts of the partnership shall be closed on the 31st day of March every year on which date a Balance Sheet and a Profit and Loss Account shall be prepared.

16. The partnership shall be one AT WILL terminable when anyone of the partners gives notice to the other three months in advance of his or her intention to dissolve the partnership and on the expiry of the said notice period, the partnership shall be dissolved and the affairs of the partnership shall be wound up in accordance with the provisions of law.


17. The terms and conditions of this Deed could be altered, added to or deleted with the mutual consent of both the parties hereto.




