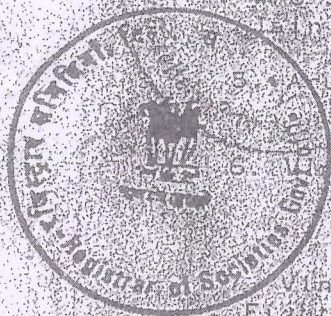

## RULES AND REGULATIONS

1. NAME OF THE SOCIETY : Abhinandan Jan Kalyan Society

2. MEMBERSHIP : The membership of the Society is open to any person or persons who has attained the age of majority & fulfills the terms & conditions of the Society, without discrimination of religion, caste, colour or creed but subject to the approval of the Governing Body. If the membership is refused to a certain person or persons, the reason for refusal shall be communicated to the person concerned. There will be three categories of members, as under:

a) Patrons : The first nominated patron will be Sh. Abhinandan Jain, who will be the only life patron of the society. Further one or more patrons may be nominated by the General Body for two years. There will be no admission and subscription fee for the patrons.

b) Founder Members : Members who applied for the registration of the Society as per Memorandum of Association column 5 under the heading Desirous Persons, will be founder members of the society & will donate Rs. 100/- (Rs. Eleven hundred Only) each at the time of formation of society. There will be no compulsory subscription for founder members.

c) Ordinary Members : Persons who believe in the aims and objects of the Society and wish to extend their co-operation in the activities of the Society & pay Rs. 100/- (Rs. One hundred Only) regularly, subject to approval of membership by the Governing Body.

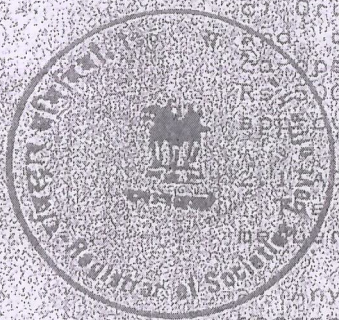
3. ADMISSION AND REPLICATION FOR MEMBERSHIP : The following will be observed for admission of a member of the Society :

Any person who has attained the age of majority can become the member of the society on acceptance of his/her application for membership by the Governing Body by its unanimous decision, provided he/she :

- i) promises and undertakes to work for the fulfillment of the aims and objects of the Society & abide by the rules & regulations of the Society.
- ii) is not debarred from any Society.
- iii) is not convicted for an offence & is of a sound mind.

### 4. SUBSCRIPTION

Patrons : No admission & subscription fee.

Founder Members : Donation of Rs. 1100/- (Rs. Eleven hundred only) at the time of formation of Society & thereafter no subscription fee.  
Ordinary Members : Rs 500/- (Rs Five hundred only) as Yearly Subscription fee.

2.3 CESSATION OF MEMBERSHIP : A person shall cease to be a member of the Society when he/she :-

- a) sends in his/her resignation in writing;
- b) becomes bankrupt or is declared a lunatic;
- c) expires;
- d) is expelled from the Society on the basis of the resolution passed by the General Body against him/her;
- e) works/acts against the interest of the Society;
- f) violates any of the rules and regulations of the Society;
- g) becomes defaulter in the payment of subscription fee within three months of its falling due.

2.4 APPEAL AND RE-ADMISSION OF MEMBERS :

Any member whose membership ceases in the society, has a right to appeal in the General Body meeting & in case of his/her appeal being accepted, he/she has to pay all his/her previous dues with a fresh admission fee.

2.5 RIGHTS AND PRIVILEGES OF MEMBERSHIP :

A member of the Society has the following rights & privileges :

- a) He can attend the General Body meeting of the Society;
- b) He can vote in the General Body meeting;
- c) He can offer himself for election to any office of the Society.

GENERAL BODY :

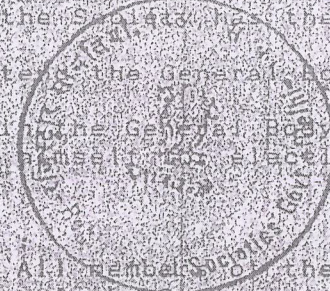
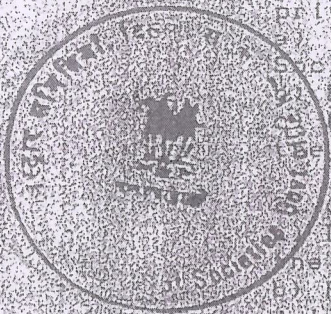
Definition : All members of the society shall form the General Body of the Society.

B) Powers, Duties & Functions of the General Body :-

- i) To confirm the minutes of the previous General Body meeting.
- ii) To appoint Auditors for audit of accounts of the Society.
- iii) To pass Budget.
- iv) To elect office bearers to run the Society.
- v) To consider any other matters.

or Quorum & notice of meeting & periodicity of meetings:-

13 The quorum of the General Body meeting shall be 1/3rd of the total members of the Society. In case the quorum is not complete the meeting shall be adjourned to any date. An adjourned meeting shall be held to consider the same Agenda & no quorum shall be necessary for such meeting.

ii) The notice of the General Body meeting shall be issued at least ten days prior to the date of meeting. Notice issued under Postal certificate or by hand shall be deemed sufficient.

iii) The General Body meeting shall be held every year.

4. GOVERNING BODY :

a) The Governing Body consists of office bearers & members to run the affairs of the Society & they are duly elected by the General Body.

b) The Governing Body shall consist of the following office bearers and members:

- i) President . . . . . One
- ii) General Secretary . . . . . One
- iii) Treasurer . . . . . One
- iv) Members . . . . . Two to Four

c) The minimum strength of the Governing Body will be three & the maximum strength will be seven including the office bearers.

d) Three office bearers & members of the Governing Body will be elected from the General Body of the Society by major votes.

e) The office bearers & members of the Governing Body shall hold the office for two years.

f) The meeting of the Governing Body shall be held at least thrice in every year of which minimum seven days prior notice will be required. Emergent meeting can be called with three days notice.

g) The quorum of the meeting shall be 1/3rd of the strength of the Governing Body.

In case of a vacancy occurring due to resignation or any other cause, the Governing Body shall fill up the vacancy from among the members of the General Body.

4.1 FUNCTIONS OF THE GOVERNING BODY :

a) To arrange finance if required from Banks, Institutions & individuals & the Governing Body as a whole is liable for its return.

b) The Governing Body shall make plan for the future programmes of the Society.

c) The Governing Body shall appoint, terminate & fix the duties of any staff.

d) The Governing Body will publish literature, propagate other system & will approach the public, other associations, agencies, Government departments in the interest of the promotion of the objects of the Society.

#### 4.2 POWERS AND DUTIES OF THE OFFICE BEARERS :

a) President : He will be the head of the Society & will preside all Governing/General Body meetings. In case of certain emergencies, he can incur expenditure upto Rs. 2500/- for which the approved of the General Body shall be obtained in next meeting.

b) General Secretary : He will conduct the correspondence of the Society, maintain all records, issue notices of meetings, draw Annual Reports, prepare minutes of the General/Governing Body meetings and carry out any other duty entrusted to him in the interest of the Society.

c) Treasurer : He will collect funds, issue receipts, make authorised payments on behalf of the Society and incur contingent expenditure upto a maximum of Rs. 1000/- in a month which will be got duly approved in the Governing Body meeting.

5. MANAGING COMMITTEE : Managing Committee can be formed for running of the institutions. This managing committee will control the day to day working of the institutions.

#### 6. SOURCES OF INCOME & UTILIZATION OF FUNDS :

The income shall be raised through the following sources.

- a) By donation & special contributions;
- b) By membership admission and subscription fee.
- c) By grants of Government grants.
- d) By conducting social, informative & cultural programmes.
- e) Fees from the students.

The income raised through the above said sources shall be utilized for fulfilling the aims and objects of the Society.

7. FINANCIAL YEAR : The financial year shall be from 1st day of April to the 31st day of March of next year acc. to English calendar.

8. AUDIT OF ACCOUNTS : The accounts of the Society shall be audited every year by a Chartered Accountant, appointed by the Governing Body.

9. OPERATION OF BANK ACCOUNT - The bank account shall be opened in any nationalised Bank in the name of the Society & shall be operated by president with treasurer or General Secretary.

10. ANNUAL LIST OF MANAGING/GOVERNING BODY - Once in every year a list of the office bearers and members of the Governing Body of the Society shall be filed with the Registrar of Societies, Delhi as required under Section 4 of the Societies Registration Act of 1860.

11. LEGAL PROCEEDINGS -

a) The Society may sue or may be sued in the name of the president, General Secretary as per provision laid down under Section 6 of the Societies Registration Act of 1860 as applicable to the Union Territory of Delhi.  
b) Any amendment in the memorandum of Association or rules will be carried out in accordance with procedure laid down under Section 13 & 12-A of Societies Registration Act 1860.

12. DISSOLUTION & ADJUSTMENT OF AFFAIRS

If the Society needs to be dissolved, it shall be dissolved as per the provisions laid down under Section 13 & 14 of the Societies Registration Act of 1860 as applicable to the Union Territory of Delhi.

13. APPLICATION OF THE ACT

All the provisions under all the Sections of the Societies Registration Act 1860 as applicable to the Union Territory of Delhi shall apply to this Society.
