## 4. Objects of the Trust:-

- a) Main object of the Trust is the reception and treatment of persons suffering from illness or mental defectiveness, or for the reception and treatment of persons during convalecence or of persons requiring medical attention, or rehabilitation, solely for philanthropic purposes, and not for purposes of profit, and that too irrespective of caste, creed and community.
- b) The Auxilliary object of the Trust are to extend financial help to the poor for medical relief or if circumstances warrant for other charitable purposes irrespective of caste, creed or community either directly or through other institutions.
- c) The Trust is empowered to engage in any legitimate activity which is incidental or conducive to the attainment of the main object of the Trust.

# 5. Board of Trustees :-

- a) For the time being the second party to this Deed

  Rev.Sr.TARSY shall herself be the SOLE TRUSTEE.
- b) Within three months from the date of registration of the Trust Deed, the Regional Council of the Settlers, shall nominate 3 to 7 members with proper designation either from themselves or from other members of the Region specifying one among them as the Chief Trustee by name ADMINISTRATOR and another as the CHAIRPERSON.

- c) The Settlers are free to change their nominees on the Board of Trustees from time to time, including the ADMINISTRATOR & CHAIRPERSON.
- d) Generally the members of the Board of Trustees are not entitled for, any remuneration but all expenses met by them for the Trust shall be reimbursed to them. But the Board Members who are devoting their Full time attention for the Service of the Trust are entitled for remuneration fixed by the Board of Trustees from time to time.
- e) The Board of Trustees shall meet as often as required and at least once in a Calendar year and adopt the annual accounts and forward a copy of the same, to the Settlers. The Administrator shall serve the notice for meeting in consultation with or at the direction of the Chairperson. The director shall maintain the minutes of the meeting duly signed by the Chairperson or the person presiding over the meeting.
- f) The meeting of the Board of Trustees shall be presided over by the CHAIRPERSON, and in her absence by a member of the board nominated by the CHAIRPERSON.
- g) There shall be a days notice for a Board Meeting unless waived by all the parties eligible to get the notice.
- h) The quorum for the Board Meeting shall be 1/3 of total members or 3 whichever is less.



## 6. Power and Duties of the Board of Trustees:-

All assets and properties of the Trust shall vest with the Board of Trustees and in the name of the CHAIRPERSON. The Board of Trustees shall have the following powers and duties.

- a) To Solicite funds, receive donations, grants subsidies
  Scholarships etc. of any kind towards Corpus or otherwise,
  with permanent obligations or otherwise, whether in
  cash or in kind.
- b) To incur all kinds of capital and revenue expenditure which will help in attaining any or all of the objects of the Trust, such as acquiring land, constructing building and equiping it giving education and training, paying fees, meeting and traveling expenses of students and trainees etc.
- c) To administer and control the affairs of the Trust,
  the Trust properties, the institutions, and establishments belonging to the Trust, or under their management.
- d) To invest the funds of the Trust in any manner they deem fit consistent with the objects of the Trust and in the interest of the Trust, provided such investments in immovable properties shall be subject to the approval of the Regional Council of the Settlers of the Trust.
- e) To borrow any amount either on pledging the assets
  of the Trust or otherwise, from individuals, banks,



- f) To, acquire, alter extend demolish any of its assets, movable or immovable and to dispose of the same whenever found necessary in the best interest of the objects of the trust.
- g) To try to recoup the cost of medicine, services and facilities, rendered to the sick, to the extent they can offord to meet the same.
- h) To form committees and prescribe duties and rights for them to assist the Administrator in managing the affairs of the Trust.
- i) Start institutions at any other place or to takeup new activities whenever necessary or to take over and manage any institution or activity now carried on by others, as long as it is found to be adventageous to achieve the main objects of the Trust, subject to the approval of the Settlers.
- j) Subject to the approval of the Settlers, to join cooperate or amalgamate this Trust, with other similar Trust, or fund or institutions as the Trustees think fit.

# 7. Powers and duties of the Administrator:-

Subject to the General Control of the Board of Trustees, the Administrator shall have specific powers and duties mentioned below:-

- a) To work manage, control and supervise the affairs management of the properties now or hereinafter belonging to the Trust and develop them.
- b) To enter into any contract or agreement for and on behalf of Trust for any of the purpose concerning the routine activities/affairs of the Trust, which are beneficial to the interest of the Trust.
- c) To appear and act for and on behalf of the Trust in all legal proceedings before any competent authority.
- d) To appoint and constitute advocate or other attorneys, whenever necessary and to remove them whenever he feels such removal is necessary.
- e) To take loans or borrow money, as decided by the Board of Trustees and to execute promissory notes, bonds or the like for the same and to discharge the same by repayments.
- f) To gather funds towards corpus or otherwise, for the Trust by way of donations or otherwise, from any persons ar institutions either in cash or in kind for the purpose of the Trust.
- g) To spend the income earned or the income of the future for any or all of the objects of the Trust, either directly or by contributing to other genuine institutions to be spent for the purpose of the Trust.
- h) To accumulate the income, if necessary, for attaining the objects of the Trust in future and to set apart the whole or part of the income for the corpus of the



- i) The Administrator shall sue and be sued for and on behalf of the Trust, provided that the Board of Trustees shall have the power to authorise any of its other members to represent the Board of Trustees in any legal or other proceedings, under special circumstances.
- j) The Administrator shall exercise and perform such powers and duties as the Board of Trustees may from time to time determine or assign or authorise her to do.
- k) To do any all acts and deeds and things necessary for the efficient management and administrator of the Trust and other properties of the Trust.
- 1) The Administrator shall have the powers to delegate her duties and functions to any other members of the Board of Trustees or member of the Staff of the Trust, with the consent of the Board of Trustees.
- m) All acts, deeds and things lawfully done by the Administrator by virtue of these powers shall be binding on the Trust.

# 8. POWER OF THE SETTLERS OF THE TRUST :-

The Settlers of the Trust, Viz. the Regional Council of the Medical Sisters of St. Thomas Region or their successors shall have the power to depute any person to inspect the accounts and the affairs of the Trust and to issue any direction whatsoever necessary to the

## 9. Bank Accounts:

The Board of Trustees shall authorise any member, or members of the Board of Trustees to open and operate jointly bank accounts with any bank as regards the funds of the Trust are concerned.

#### 10. The Accounts :-

The accounts of the Trust shall be closed on 31st March every year and it shall be audited by an auditor appointed by the Settlers. The audited statement with the explanations of the Board shall be submitted to the Settlers within 30th September every year or within the time extend by them.

## 11. Miscellaneous:-

- a) Any provision in this Deed except the object clause No.4 and Saving Clause No.12 and this clause may be amended, annulled or substituted by the Settlers if requested by the Board of Trustees and such amendments or alterations shall come in to effect only when those are approved by the Commissioner of Income Tax.
- b b) In this event of the Trust becoming impossible to function in accordance with the provisions of the Trust Deed, the assets of the Trust after discharging of all its debts and liabilities shall be dealt with according to law and with the approval of the Settlers either by transferring to similar registered Charitable Society/Trust or it shall vest with the Government.

## 12. Saving Clause:-

- a) This is Charitable Trust and it is expressly declared that no part of the Trust Property or its income shall be applied for any purpose, other than charitable purposes, and no part of the income or funds of the institution shall be divided among the members by way of profit. It is further provided that expenses incurred for the consolesence of the patient according to his/her religious belief will be treated as charitable expenses only for the purpose of this section.
- As and when the eclesiastical status of the settlers "ST.THOMAS REGION" get elevated to a VICE PROVINCE OR PROVINCE, all the powers now give to the Region and its councellors shall stand transfered automatically to the Vice Province or Province and the Councellors accordingly.
- 13. The value of the Trust Fund is R. 1,000/- (Rupees One thousand only).
