(i) Name of the firm:

The name of the firm will be "Cristal Diagnostic & Research Laboratory" and in case of necessity the partners may carry on business in some other name also.

(ii) Principal place of business:

The Principal Place of business shall be at No.11/2,2nd Cross, Arthanari Nagar, Salem-636004 and the partners may shift the principal place of business or open branch or branches as they may decide from time to time.

(iii) Nature of business:

Interest may be decreased by mutual consent of the partners depending upon the profit position of the firm.

(vii) Remuneration to partners:

The parties of the first and second parts shall be working partners and are entitled to draw salary. Salary will be payable annually as under:-

1. Mr.P. Pasupathi - Rs. 6,50,000 P.A 2. Mrs.M.Deepa - Rs. 4.50,000 P.A

The above salary will be charged against the profits of the firm as per provisions of Sec.40(b) of the Income tax act. If the profits are not sufficient, the above salary will be reduced as per provisions of Sec.40(b) of the Income tax act.

(viii) Division of net profits and losses:

The net profit or loss of the firm after deduction of interest payable to partners and salary to each partner as per aforesaid clauses will be divided as under:

1. Mr.P.Pasupathi - 60% 2. Mrs.M.Deepa - 40%

(ix) Accounts:

Accounts will be maintained and closed on the 31st day of March of every year and the profit or loss being drawn as on that date, Shall be divided among the partners as per above ratio.

(x) Duration:

The business of partnership will be one of that "AT WILL", but death or retirement of a partner shall not dissolve the firm. Partnership business will be carried on by the remaining partners by taking over a legal heir of the deceased or any other person by mutual consent.

(xi) Bank Accounts:

The Partners shall have the authority to open one or more bank accounts in the name of the Partnership, which shall be operated by either of first and second parts individually.

(xii) Conduct of Business:

The partners shall have right to make and give receipts, release and other discharge for claims and demand of the partnership in the ordinary course of the business. They have right to draw, sign and negotiate bills of exchange, cheques, hundles & other negotiable instruments for and on behalf of the partnership.

(xiii) Loan:

If funds are necessary for the carrying on of the business, over and above the capital contributed by the partners, loans may be borrowed from banks, individuals or other financial institutions and in such cases the loan documents shall be signed by first and second parts jointly.

(xiv) Goodwill:

The estate of deceased partner or a retiring partner will not be entitled to any share on account of goodwill which will continue to be the property of the firm.

(xv) Arbitration:

In the event of difference of opinion among the partners the same shall be referred to a Body of Arbitrators whose decision shall be final in the matter.

(xvi) Retirement:

Any partner intending to retire can do so by giving one months notice to the other partner in writing so as to coincide with the accounting year of the firm. The retired partner shall be paid such sum as standing to the credit of his account on the date of retirement and shall not be entitled to any share in the good will of the firm.

(xvii) Act:

For all other things, for which to specific provision has been made in the deed of the partnership, the partners are bound by provisions of the Indian partnership act 1932.
