1. The Name of the Company is

3.(a)The objects to be pursued by the company on its incorporation are

1. To carry on the business of establishing, running, developing administering Hospitals, Nursing homes, Clinics, Medical research centers, for treating patients in all branches of medicines.
2. To provide treatment including dialysis and transplant for persons affected by Renal and urology related diseases.
3. To carry on the business of establishing, running, developing, setting up pharmacies, medical stores, pathology, and other clinical laboratories, X ray, scan and other, diagnostic centers, dialysis centers, cafeteria, optic centers, blood bank and eye bank.

3.(b)Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To apply for purchase or otherwise acquire any patents, license, concessions, and the like conferring any exclusive or non-exclusive or limited right to use any secret or other information as to any invention which may seem capable of being used for any of the purpose of the company.
2. To enter into partnership or into any arrangement for technical/financial or for sharing Profits, union of interest, co-operation, joint venture, reciprocal concession or there wise with any person or persons carrying on or engaged in or about to carry on or be engaged in or any business or transaction which this company is authorized to carry on.
3. To enter into partnership with any person or persons carrying on the same business which the company is authorized and carry on the same business with them to share the profits and the assets and liabilities of the firm and, if desire, to undertake or takeover the entire business and the assets and liabilities of the firm in the manner as agree by the partners of the firm and the company.
4. To enter into any agreement or arrangement with any foreign persons for technical, financial or commercial help and collaboration and to do all such things as are necessary for the attainment of the object in the best interest of the company.
5. To send any director or officer of the company at the company's expenses abroad for Special training in arts, science, technology on such terms and conditions as the company may deem fit.

9. To construct, maintain and alter any buildings, or works necessary or convenient for purpose of the company.
10. To construct, improve, maintain, develop, work, manage, carryout, or control any roadways, railways, bridges, reservoirs, water courses warehouses, electric workshop, stores, and other works and conveniences which may seem necessary, directly or indirectly to advance the company's interest and to contribute subsidise, or otherwise assist or take part in the construction, improvement, maintenance working, management, carrying out or control thereof.
11. To adopt such means of making known the business of the company or of any company in which the company is interested as may seem expedient and in particular by advertising in the press, by circulars by establishing competitions and granting prizes reward and donations.
