

law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the Powers, provisions, agreements and declarations hereinafter contained.

- That the name of the trust shall be called "KUNWAR DAS WELFARE TRUST" and its office shall, for the present, be 708, VISHESHERPUR, POST: SHEETALA CHAUKIA, AZAMGARH ROAD, JAUNPUR 222106 (UP) District: Jaunpur, State: Uttar Pradesh and/or at such other place or places as the trustees may decide from time to time.
- 3. The object for which the trust is established are Education, Relief to poor, Child & Women Welfare, Medical relief or advancement of any other object of general public utility and for such purpose as, but not involving the carrying on of any other activity for profit:-
- a. To spread and promote, education, learning or training of Computer in all its branches is such a manner as the trustee may think fit including:
- Imparting education and training to economically backward and deserving students without any distinction of caste, color or creed.
- Establishment and maintenance of schools, colleges, study centers and other institutions for imparting education and training of students.
- iii) Establishment and support of fellowship, scholarship and prizes for enhancement of education and training.
- b) Medical relief in such manner as the trustee may think fit, including:
- Endowment to and help or support to hospitals, Health centers and dispensaries.
- ii.) Grant of Medical help to the poor and grant of medical help to deserving persons during epidemic, famine, flood, earth quake or any unforeseen calamity or war like operations.

- c) Other objects of general public utility, includes:
- To construct, to built-up, to-develop, to maintain, to run, to manage, to take over the community hall, dharamshalla for poor people, sarai, cultural centers, rest house or any accommodation for the welfare of the people. To buy the land from government authorities or any other private organization or any person.
- To establish and develop institution for the physically handicapped and disabled or mentally retard person any to provide them education, food, clothing or other help.
- To help to the widows, the needy, the orphans, the old destitute and the in capacitated / handicapped in the form of monetary assistance, medical aid, scholarship for education.
- Poverty alleviation through Government and Non-governmental projects & Schemes.

- Focus on self employment and employment as per the trust needs such as Tailoring, Electronics, Communications, Computers, Information technology, Gemology, Crafts, Arts, Handicrafts, Lathe works, Petty shops, Cafeteria, Staring small Enterprises etc.
- Entrepreneurship Development Programme.



- Treatment and creating awareness of Ignorance about hygiene, Drug abuse, Alcohol, HIV/AIDS, Tuberculosis & Hepatitis-B removal. Providing treatment, Medical Assistance and Ambulance facilities among the poorest of poor and establishing Rural Health centers.

- To create awareness in the community to protect, preserve and maintain the Environment for a healthy ecological system.
- To engage in programs and activities that promotes sustainable Human and Social Development.

- To take all necessary steps to ensure the betterment and improvement of the economic and general conditions of living in the area of operation.
- To provide Health Education, Physical Education and various Martial Arts, Kung-Fu,
   Karate, Jeet Kune Do Ideology, Philosophy and skills.
- To collect, publish, distribute and make available to the members of the society and public at large, literature, circulars, books bulletins, records and information in whatever manner know to science or to arrange seminars on education programmes which are of use, interest and importance.
- To arrange common place for meeting of the members of the society for the purposes of common discussions of common problems and encouragement of thrift advancement of welfare ideas mutual assistance production of the interest of the members of the society.

- Physical, Mental and Social well being of the women and children.
- Education and Awareness about AIDS, Cancer, Hepatitis, TB and other diseases and pursue research in the area of medicine and general health.

- The trust may provide consultation services to other organization (Govt. or Non Govt.) in the areas of health and environment with or without charges.

- Establishment and maintenance of and support to hostels and boarding house and grant of boarding and lodging to economically backward and deserving students upon such terms and for such period in each case as a trustee may think fit.
- Awarding scholarships, fellowship for the purpose of undertaking higher education and research work in any branch of computer science, computer engineering to such deserving students of scholars who can not afford and have no means to under take such work or studies on such term and conditions the trustees may think fit but without any distinction of caste color and cread.
- To establish, maintain and support libraries, museums and reading room for advancement of education and knowledge.
- To conduct all kinds of vocational & job oriented courses.
- To enter into joint venture or collaborate with other institutions operating in the filed in any part of the world to incorporate latest technology and facilities available for imparting education and training ad research in the field.
- To provide free legal aid for poor.
- To Plant/run Orphanages, crèches, Worship places, churches, old age homes, for minorities.
  - To organize assemblies, Meetings, counseling's, discussions, open air meeting, conventions crusades on social issue etc.
  - To start/run charitable hospitals/clinics for the treatment of the sick and poor, who can not go to expensive doctors.
  - To save Poor's from excess drinking and smoking, drugs etc.
  - To provide orientation to SC/ST, MINORITIES boys and girls that they will be able to solve their socio problems.



- To arrange fulfill marriage ceremony for the social welfare & give certificates. Funnel arrangements for the charity purpose.
- To conduct courses and coaching classes for the benefit of Christian & other community & issue the necessary certificates for the community.
- The trust shall open office anywhere in India.
- Relief to the poor which includes:-
- Establishing or rendering help to any institution for the alleviation of human suffering.
- Subscription, contributions and/or donations to any public charitable trust or fund or institutions for promotions of any public charitable objects.
- iii) The creation, maintenance, supply or of support of garden, gymnasiums, physical culture centers, sport centers and other means or recreation for advancement of sports, Health and Hygiene.
- 4. For the furtherance of the object of the trust the investment or use of Trust fund for the time being in force, the trustees will have the following powers:
- i) To accept any donations, contribution, grant, gift or subscription in cash or in kind form any person, body of persons, trust, govt. towards the corpus or trust fund to meets the objects mentioned herein before.
- ii) To apply the whole of part of the income of the trust funds or accumulation thereof or whole or part of the corpus of the trust funds, on any one or more of the objects of the trust, as the trustee may in their direction from time to time determine.
- iii) To invest or deposit trust funds and incomes of the trust in the forms and modes as prescribed under section 11(5) of the income tax act and rules made there under :-
- iv) To purchase, sell, mortgage, dispose of or otherwise deal with any property for trust.





- v) To let out demise any immovable property comprised in the trust fund for such period and at such rent, on such terms and conditions as the trustee in their discretion may think fit.
- vi) To open account with any bank, or banks to operate such account and to give instructions to the bank and to provide for opening and operation of such account by the trustee or by any agent appointed by the trustees.
- vii) To adjust, settle, compromise, compound, refer to arbitration all actions, suits claims, demands and proceedings regarding the trust fund.
- viii) To appoint constituted attorney or agent or to delegate to such attorneys or agents or any of the power vested in the trustee under these presents and from time remove such agents and to appoint others in his or their place.
- ix) To appoint or make provision for the appoint of any person (including all or any of the trustee as committee or administrator on managing trustee (s) or otherwise) for the purpose of the trust in such manner and subjects to such rules and regulations as the trustees may prescribe and also to appoint or provide for the appointment of separate trustees to hold any property or any fund or investments subject to such rules and regulations as the trustee may from time to time fit.
- x) To make, alter or modify schemes, rules and regulations for carrying out the objects of the trust and the management of the affairs thereof and running any institutions in furtherance of the objects of the trust.
- xi) To start, abolish, discontinue and charity or charitable institutions for the benefit of general public and to impose any condition to any subscription or donation made by them.
- xii) To set apart the whole or part of these incomes or the corpus of trust fund of part of the object of the trust.

- xiii) To take over acquire manage control or aid any existing institution or institutions having objects either wholly or in part a similar to the object of this trust an on such terms and conditions as may be through expedient.
- xiv) To transfer all or any part of the property asset, liabilities and engagements of this trust to any one or more of the charitable trust, societies, institutions or associations.
- 5) It shall be lawful for the trustee to give aid by way of donation out of the income of corpus of the trust fund or otherwise to different charitable institutions, societies, organization or trust to enable such institutions, societies, organization or trust to start maintain or carry out such charitable objects.
- 6) The trustee shall have the power, that instead of acting personally to employ and pay any agent to transact or to be any act whatsoever in relation to the trust of these presents including the receipt and payment of money with out being liable for loss and shall be entitled to be allowed and paid all charges and expenses incurred there by.
- 7) It shall be lawful for the trustee to borrow moneys either on the security of any property comprised in the trust fund or otherwise/for all or any of the purposes of these presents and it shall be lawful for the trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may decide from time to time.
- 8) The receipt of a persons authorized by the trustees or a resolution of the board of trustees, for any money paid or any property transferred or delivered to the trustees in execution of any of the power thereof or for purchase moneys or any property authorized to be sold shall effectually discharge any persons so paying or transferring or delivering.





- 9) The trustee will be entitled to receive any remuneration as trustee but may reimburse themselves of all expenses actually incurred by them in connection with the trust on their duties relation thereto.
- 10) The number of the trustee shall not be less be two and more than fifteen at any time. If the number of the trustees shall fall below there, the trustees shall not except for the purposes of filling any vacancy, as so long as the numberies below the said minimum.
- 11) The trustees for the time being will be at liability to appoint additional trustee(s) within the number mentioned above for such period or on such terms as to retirement and reappoint as the trustees for the time being consider proper.
- 12) The trustees, will be at liberty to resign on giving one month's notice of his intention to do so.
- 13) The trustees once appointed, shall hold his office until he resign or is declared insolvent or convicted by a court for criminal office involving moral turpitude or otherwise become until or incapable to acting at any time. Any trustees on account of any gross misconduct on the part of any trustees in his public life or pertaining to the affairs.
- 14) The general administration/affairs and the presents of this deed shall be conducted by the chairman.
- 15) The trustees may from time to time frame by-laws rules and regulations for the conduct of the affairs of the trust its office bearers and employees.
- 16) The amendments of the trust deed shall be made by two third majority. The trustee may from time to time frame rules for the conduct and regulation of the meetings of the trustees.
- That one third of the trustees shall form a quorum for meeting of the trustees.





- ii) All the matters will be decided by majority. In the vent of any tie, the settler (in his absence trustee presiding over the meeting) shall have a casting vote.
- iii) Resolutions passed without any meeting of the trustees but by circulation thereof and evidenced in writing under hands of two third of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.
- 17) The trust hereby created shall be irrevocable.
- 18) That we, the settler trustee, shall be entitled to nominate a success or to myself. The successor so nominated by me shall be chairman of the trust after my death or incapacity to act as chairman, and will act along with other trustees. Myself, my successor, will be entitled to nominee another person in the place of the one decreasing or resigning, but if he does not so nominate, the surviving trustees will continue to function and administrator the trust.
- 19) The managing committee shall consist of all the trustee and shall elect office bearers of the managing committee from the trustees consisting of chairman, cashier, advisor.


