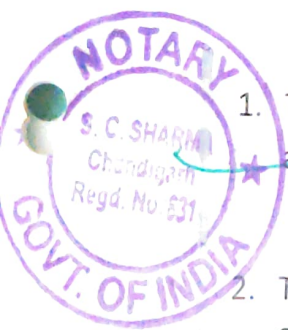
DEED OF SOLE PROPRIETORSHIP

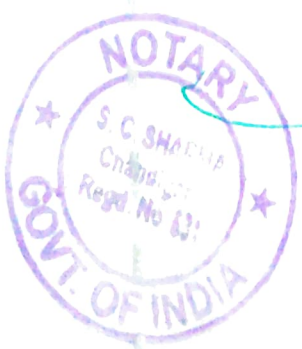

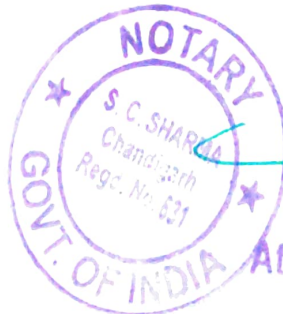
