**Note-4:** Z score value between "0 to  $\pm 2$ " are texted in green colour. Z score value between " $\pm 2$  to  $\pm 3$ " are texted in orange colour. Z score value  $> \pm 3$  are texted in red colour.

**Note-5:** Homogeneity and stability testing of PT sample were done as per ISO 13528:2015 standard. To pass homogeneity test, between sample SD (Ss) should be smaller than the check value (0.3\*SDPA). To pass the stability test, average difference in measurement values of first and last day sample  $(\bar{x}-\bar{y})$  should be smaller than the check value (0.3\*SDPA).
