



- 1). That three parties cited supra are the partners of the firm **"DOCTORS LABORATORY"**.

11). The First Second and Third Parts of the Parties shall borrow any borrowings from the financial institutions or from Banks or from outside parties for the purpose of the business **jointly**.




12). New partner or partners shall be admitted into the partnership with the mutual consent of the Allpartners.



