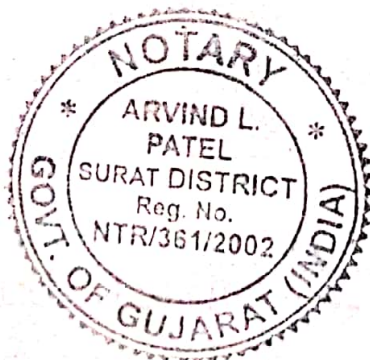

DEED OF PARTNERSHIP

2. **Rahul Maheshchandra Jariwala** aged about 44 years occupation- Business residing at A-904, Suryam Residency, Nr. Saurabh Police Station, Asarma, Surat-394510 herein after referred to as the party of the second part,
3. **Mona Samir Gami** aged about 38 years occupation- Business residing at 1003, Brahmand Residency, Opp. Western Business Hub, Pal Gam, Surat-395009 herein after referred to as the party of the Third part,
4. **Priyanka Hemanshukumar Patel** aged about 34 years occupation- Business residing at B-502, Blue Stone Building, Dandi Road, Jahangirabad, Bhesan, Surat-395005 herein after referred to as the party of the Fourth part,
5. **Frenil Chetan Munim** aged about 34 years occupation- Business residing at A-32, Aakfuti Bunglow, B/h. Big Bajar, Vesu, Surat-395007 herein after referred to as the party of the Fifth part and
6. **Divyang Babulal Shah** aged about 55 years occupation- Business residing at 4, Madhav Villa, Chhatrapati Shivaji Road, Adajan, Surat-395009 herein after referred to as the party of the Sixth part,

Whereas the parties to the above have decided to carry the business of Consultancy, investigation and Diagnosis etc. in partnership under the name and

style of "**MALAVIA ADVANCED LABORATORY**" in partnership from 1ST December, 2019 at **Registered office of business at 305, Western Shivalik, L. P. Savani Road, Adajan, Surat - 395009** as per agreed upon terms and conditions on 09/08/2011 for which the written deed is executed.

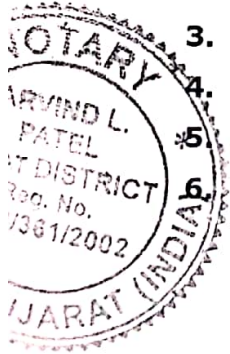
The Mutually Agreed terms & conditions agreed upon are as under.

1. That the partners of the firm shall carry on in Partnership the business of Consultancy, investigation and Diagnosis and such other business in the same under the name and style of "**MALAVIA ADVANCED LABORATORY**".
2. That the business of the firm shall be carried out at **305, Western Shivalik, L. P. Savani Road, Adajan, Surat. Pin 395009** and or at the other place as the parties hereto agreed from time to time.
3. The firm shall registered pursuant to the Indian Partnership Act-1932, and any changes which may occur in future in any kind may be notified to the registrar of firms in a statement specifying the date and nature of such changes dully signed by all partners and the certificate of the firm's registration shall be exhibited.
4. That the partners hereto divide the profit or loss of the partnership business in the ratio given hereunder

1. Arvin Kalyanbhai Malavia	50%
2. Rahul Maheshchandra Jariwala	15%
3. Mona Samir Gami	20%
4. Priyanka Hemanshukumar Patel	5%

The expression net profit/losses shall mean net profit/losses remaining after deduction of business expenses, other interest and also remuneration/salary/bonus/incentives/commission paid to partners for their services rendered to the firm and also depreciation and other charges.

5. The accounts of the partnership firm shall closed on 31st day of march every year, on which the regular profit and loss Account and Balance Sheet shall be drawn up



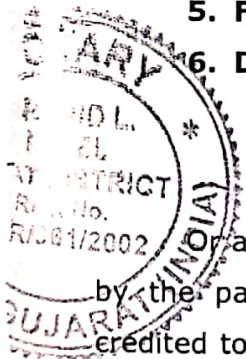
and the profit or loss as the case may be shall be divided and adjust in the capital accounts of the partners.

6. That all the parties to this indenture having agreed to actively engaged them self in conduction the affairs of the business of the firm and shall be classified as "WORKING PARTNERS" of the firm.
7. The working partner/s shall be paid annual remuneration for the services rendered by him/them during the year which shall be calculated with reference to the "BOOK PROFIT" and in the manner and limits as laid down U/s. 40(b) of the Income Tax Act-1961.or any modification or reenactment thereof, for the time being in force. The total Remuneration so calculated shall be allocated amongst the partners in the following proportions.

1. Arvin Kalyanbhai Malavia	50%

3. Mona Samir Gami	20%
4. Priyanka Hemanshukumar Patel	5%

Or a fixed monthly remuneration to working partners mutually agreed upon by the parties. The remuneration paid/payable to working partners shall be credited to their respective capital A/c as at the end of the accounting year or at any time during the year if required. When final accounts of the firm business are drawn up and the amount of the remuneration due to each of the working partners is determined. The yearly remuneration paid or payable shall be deemed to have accrued during the accounting period on the monthly basis. However, the partners may, if feel necessary; unanimously decide for reduction of salary agreed upon as detailed above for which no written agreement required to be prepared.

8. That the regular books of accounts of the partnership business shall be maintained and kept at hospital and each partner or his nominee shall be entitled to examine and take notes there from during the business hours.





9. That the bank account of the firm shall be operated by any one of the partners which can be changed mutually if required by written instruction to bank. Further it is agreed that the partners of the firm jointly authorized to borrow Finance in form of Term Loan, Cash Credit, Mortgage loan or in what so ever form of advance in the name of the firm and for the funding requirement in the interest of firm from any Banking or Private Institution by mutual understanding of the partners of the firm. Further it is agreed that the power may be given to any trustworthy person for acting on our firm's behalf for all firm's work as well as to operate upon the bank a/c, if necessary.
10. The partners shall be faithful to each other and shall not act in a way which may injure or impair the interest of the partnership business.
11. That both the party to this indenture shall contribute capital as required in the firm and maintain the sufficient credit balance till the accumulated profit in the firm is sufficient for smooth working. **The interest will be provided at 12% per annum or at the rate amended in the income tax Act, 1961, thereof for the time being in force on the credit balance standing to the credit of fixed capital a/c as on the end of the first day of the year. No interest is payable by the firm to the partners on the credit balance in their current capital a/c.**
12. Any difference arising as to the ordinary matters connected to the business may be discusses and solved mutually by the partners in the interest of the firm. No change shall me made in the nature of business of the firm without the consent of all the partners.
13. That in case of any difference or dispute between the partners as regard to any matter relating to the partnership, the same shall be referred to and decided according to the provisions in the Indian Arbitration Act.
14. Every partner shall have the right to retire from the partnership at any time by giving three month notice in writing to the other partners.
15. The partnership shall not dissolve in the event of death of any partner or retirement of any partner. The remaining partners may continue the business of the firm after deciding the dues payable to retiring/legal heirs of the deceased partners.
16. That the duration of the partnership shall be determined at the will of the partners i.e. the partnership shall be "PARTNERSHIP AT WILL".

17. That the terms and conditions of the partnership business may be altered at any time by mutual consent of all the partners for which separate deed required to be executed and shall be deemed as part of this deed.



18. That the partnership business shall be governed by the provisions of the Indian Partnership Act-1932 in all matters not herein specifically provided.
