Breakup of the work progress; final dates for target :-

1. Laboratory equipments status up to 5th June, 2019.
2. All kind of civil and electrical work to be completed by 20th June, 2019.
3. Installation and validation of all laboratories equipments by 28th June, 2019.
4. Staff selection, training to be completed by 1st July, 2019.
5. Laboratory Information System (LIS) to be installed and validated by 2nd July, 2019.

It was decided that the Lab shall function under the supervision of CMO, MCG.
