

Whereas all the parties are the permanent residents of their above mentioned addresses and all the parties have a good relationship between each other and in pursuance of present Government notification the aforesaid parties to this Reconstruction Indenture on other to have their functions as partners more fully described in this Re-construction of Partnership Deed and to avoid future litigation and disputes between them have agreed between themselves to other the terms and condition of the present partnership since verbally agreed and hereinbefore acted upon in good faith. In this Re-construction of Partnership deed First Part and Second Part Joining as Fresh Partner from 1st February 2021 and Third Part and Fourth Part will be Continuing Partners and this new Partnership Deed is the Continuation of the First Deed of MODERN made on 1st April 2014 and Notarised on 18th December 2015 with Serampore Court, Hooghly.

NOW THIS INDENTURE WHTNESSETH AND IT IS HEREBY AGREED AND DECLARED AS FOLLOWS:-

1) That the partnership business shall be carried under the name and style "MODERN" situated at Vill & PO Jangipara, Dist Hooghly, Pin 712404, West Bengal and it shall be deemed to have commences on and form 1st day of February, 2021

No. 56 under Police Station Jangipara in the District of Hooghly in the State of west Bengal which is present holded and possessed and owned by fourth partner namely SRI DIPANKAR GHOSH s/o Gadadhar Ghosh of Vill – Sukharchak, P.O. – Rajbalhat, P.S. – Jangipara, Dist – Hooghly, Pin 712408.





- 3) That the accounting year of business will be April to March.
- 4) That the space of the Business place has to decorated by all partners means cost of decoration will be distributed among the all partners.
- 5) That the present the all parties are the owner and holder of all the equipments in respect of running and continuing the said business and list of all the equipment are annexed herewith i.e., along with this Deed of Partnership which will be treated as pert and partial of this deed of partnership business, which is amounting Rs.1,30,54,000/= (Rupees one crore thirty lakhs fifty four thousand only) and as because the capital of the Partnership Firm will be Rs.1,30,54,000/= (Rupees one crore thirty lakhs fifty four thousand only) only which will be contributed as details below.

- iv) The above partners may agree to lower remuneration or agree not to take any remuneration as may be decided by and between the parties from time to time.
- 09) That the partner's personal account shall be recorded in the ledger synonymous to khatian of the partnership business and all personal transaction of each individual partner with the firm shall be entered there.
- That after the final closing of the accounting year the net profit or loss to be entered in the capital account of each individual partner either credited or debited as the case may be.
- 11) That for the progression of the firm if the bank over draft loan any hypothecation from any schedule bank/banks are required the same shall be made by the consent in writing of all partners.

- That in case of either partner being adjudicated involvement he/she will loss all his/her rights, title and interest in the property of the firm 1st business immediately on such order of adjudication being passed against him/her.
- 17) That all the maters not provided herein the provision of the Indian Partnership Act IX of 1932 should come into force and also time of statutory amendments and modification shall also be enforced up to this deed of partnership.
- That any of the above terms may be varied, altered or added to by the mutual consent of the partner hereof for the purpose of greater interest of the partners as well as the firm to be expressed in writing or implied from conduct.
- 19) That on partner shall be able to act individually involving this deed of partnership without written consent of other partner.
