The authorization, conveyed above, is subject to the following conditions:-

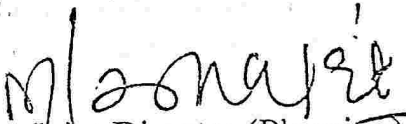
1. All the conditions as contained in Govt. Order No. 54-PD of 2018 dated. 20-02-2018 shall be implemented in letter and spirit.
2. The procurement and tendering process shall be completed and all budgeted works must be allotted and supply orders issued or procurements made by the specified timeline.
3. DPRs, wherever required shall be framed after taking into account soil testing and other technical inputs. It shall be ensured that tendering process commences only after the DPRs are prepared, Administrative Approval and technical sanctions are accorded and any other applicable requirements have been met. Scope of work shall neither be changed nor extended without proper authorization from competent authority and availability of funds.
4. No expenditure shall be booked on revenue items like information, Publicity, Trainings, field functions/ fairs etc.
5. The authorization shall not be applicable for Negotiated Loans (NABARD/LIC/REC) for which the utilization is linked to the actual lifting of loan component from the Financial institutions / Finance Department.
6. The authorization shall not be applicable to the central share of centrally sponsored schemes/ PMDP for which funds are to be utilized only after these are released by the concerned Union Ministry.

7. The execution of works shall be restricted to approved schemes only within the approved cost and no liability shall be created ensuring financial discipline in the system, until specifically authorized by the Planning, Development & Monitoring Department.
8. All necessary Administrative Approvals and Technical Sanctions shall be obtained prior to the execution of works/ projects. In case of cost revision, necessary revised Administrative Approval shall be obtained from the Competent Authority for incurring expenditure.
9. For implementing the commitments made by the Hon'ble Chief Minister and the DDCB decisions of the Hon'ble Chief Minister, proper DPR's shall be framed and execution shall start after the approval of Planning, Development & Monitoring Department and shall be the first charge on the regular Capex Budget in succeeding years.
10. All HODs will carry out a comprehensive exercise to remove duplication/ replication of schemes to ensure completion and consolidation of on-going schemes and to make the Capex Budget objective oriented.
11. The funds shall be utilized after fulfilment of all the codal procedures/ formalities and re-appropriation/diversion shall not be made at any level.
12. Expenditure shall be booked under proper head of account.
