

**MEMORANDUM OF UNDERSTANDING (MOU)**

This MOU is signed between



The terms & conditions are detailed as under:

1. The first party will arrange to collect the specimen from the Hospital, the second party on a need basis as and when intimated.
2. The first party will hand over the report to the patient and also email the report to the Hospital of the second party adhering to the TAT (Turnaround time) list provided by the first party for their acceptance by the second party is attached as Annexure – 1.
3. In case of any reporting errors by the first party, the test will be carried out again at no additional cost to the patient/Hospital.
4. The first party has provided a Price list with item specification to the second party for their acceptance by the second party is attached as Annexure – 2.
5. The second party agrees to honor the bills of the first party on a monthly basis within 10 days of the receipt of the bill.
6. The MOU is valid for a period of five years from 01-01-2020 to 31-12-2025.
7. The MOU shall be extended for another five years by mutual consent
8. This agreement could be annulled by either party by giving one month notice in writing.


