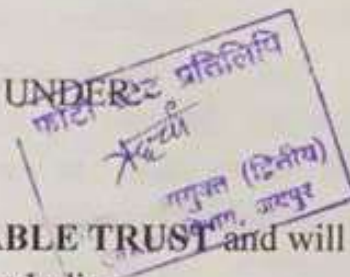

MINUTES OF PROCEEDINGS

POWER OF TRUSTEES

INVESTMENT OF TRUST PROPERTY

18. Share, funds and securities that they shall actually received notwithstanding their signing a receipt jointly with other for the sake of conformity and shall be answerable and accountable for their accounts receipts and defaults The Trustees shall not be answerable one for the other or others of them nor for any banker, broker of any person with whom or into whose hand any trust money or securities may come to be deposited or given nor for the insufficiency of any stock. Share funds. Of other loss unless the same shall happen through their wiful default, misconduct, or negligence respectively.

DELEGATION OF POWER BY TRUSTEES

23. The Trustees may delegate by resolution in writing any of their power to committee consisting of such person or persons whether member of their body or not as they may think fit and proper. The Trustees shall be entitle to be paid all costs and expenses incurred by them for carrying out the object of the Trust.

POWER OF AMENDMENT, MODIFICATION, ADDITION, SUBSTITUTION, DELETION,

24. The Chairperson has the power to amend, add substitute, and delete any one or more of the clause (other than the object clause) with the consent of chairperson.

FAILURE OF THE TRUST

25. If the Trust fails, all funds available with it shall be handed over any such public charitable trust or trusts created for similar object as may be approved by the legal Heirs of Trustees. Trustee of Trust will be from blood- Relation ship only legal heirs can only be trustee of this Trust.
