


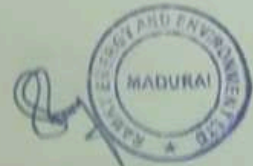
AGREEMENT OF SERVICES

and

Whereas Ramky Energy & Environment Ltd., Madurai has established a Common Treatment facility in accordance with the Bio-Medical Waste (Management and Handling) Rules, 2016, for collection, transportation, treatment and disposal of the bio-medical wastes generated by the "Health Care Establishments".

Whereas The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District *list of hospitals under the jurisdiction of party B*) are generating Bio-Medical Wastes which need to managed in accordance with the Bio Medical Wastes(Management and Handling) Rules, 2016 of Govt. of India as amended subsequently.

**Terms and Conditions:**


Whereas REAEL, Madurai offers to provide the services required for Collection, Transportation of all Biomedical Waste (including empty plastic saline bottles, pouches and plastic cans from the government medical college & hospitals) which are primarily collected from all the source points within the hospitals and stored in a common storage room by the concerned hospital staff and its final disposal at the Common Bio-Medical Waste Treatment Facility as per Biomedical Waste ( Handling and Management ) Rules, 2016, third amendment 2003, The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District *list of hospitals under the jurisdiction of party B*) to be complied with the above said rules on a "user – per – principle" at

The above rate is inclusive of all costs towards collection and transportation of biomedical waste from the hospitals and its proper end disposal as per the Bio Medical Wastes (Management and Handling) Rules, 2016 of Govt. of India.

The empty plastic saline bottles, pouches and plastic cans collected along with the biomedical waste from the hospitals should be weighed in kilograms in different type of categories as mentioned .

If the collected biomedical waste including empty plastic saline bottles, pouches and plastic cans from the hospitals are not lifted as mentioned above by REAEL, Madurai, then the payment to the service provider, the Common Bio-Medical Waste Treatment Facility by The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District will be paid.

If the payment against the submitted bills ( which are submitted in full and complete shape ) is delayed beyond 21 working days from the date of submission, an interest @ 6% may be paid to service provider, the Common Bio-Medical Waste Treatment Facility by The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District

All complaints (if any) shall be attended to in the shortest possible time, (48 hrs) by the service provider under the jurisdiction of REAEL, Madurai and the client under the jurisdiction of The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District (Authorized signatory of the agreement) .

The client under the jurisdiction The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District has the right to enter the operational premises of service provider, under the jurisdiction of The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District at any time to ascertain the final disposal of biomedical waste collected from their hospital.

Agreement can be terminated by giving one month notice by both the parties, client and service provider.


REAEL, Madurai and The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District here by undertake to adhere to this "Agreement of Service" for a minimum period of THREE YEARS (from the date of approval from 07.09.2021 TO 06.09.2024)

**Roles and Responsibilities of "Ramky Energy & Environment Ltd., Madurai"**

1. Prior planning of the coverage area and its operation with near approximate timings should be informed to the head of the Government Hospitals. (Medical Superintendent, Hospital superintendent / Chief Medical officer / In-Charge Medical Officer / Regional Administrative Medical Officers, whoever the case may be)
2. Any change in the plan should be intimated well in advance to the head of the Government Hospitals. (Medical Superintendent, Hospital superintendent / Chief Medical officer / In-Charge Medical Officer / Regional Administrative Medical Officers, whoever the case may be)

3. REAEL, Madurai is responsible for the safe transportation of the Bio Medical Waste from the hospital premises to the Common Treatment Facility as per the norms prescribed by TNPCB. REAEL, Madurai will arrange alternate vehicle during the period of vehicle breakdown for the transportation.

4. The quantity of (weight) of Bio Medical Waste lifted from each hospital should be entered in a register maintained in that particular hospital and should be endorsed by the concerned hospital authority who has been designated for this work.

6. REAEL, Madurai is responsible for following all statutory rules and regulations prescribed by Tamil Nadu Pollution Control Board prevailing on the day for the services and for keeping and producing all the records required in this regard by the authorities.

7. REAEL, Madurai will make periodic inspections of the The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District (list of hospitals under the jurisdiction of party B) regarding Collection and Segregation of Bio – Medical Waste (Management and Handling) Rules 2016 of Govt. of India.


8. REAEL, Madurai shall provide the training once in three months free of cost about segregation of bio medical waste as per color coding provided by TNHSP, collection of waste in colour coded bags as well as occupational safety in management and Handling of Bio Medical Wastes.

9. REAEL, Madurai shall send the bill in full and complete shape for the preceding month, by the 5th of the next month and the same shall be paid by The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District through DD or Cheque drawn in favour of M/s. Ramky Energy & Environment Ltd payable at Madurai within 21 working days from the date of submission.

**Roles and Responsibilities of The Deputy Director Of Health Services, Virudhunagar, Virudhunagar District**

1. The Medical Superintendent, Hospital superintendent / Chief Medical officer / In-Charge Medical Officer / Regional Administrative Medical Officers, whoever the case may be, should identify a responsible / nodal staff in their hospitals, for handing over the collected biomedical waste from the hospitals to REAEL, Madurai and the same should be communicated to REAEL, Madurai with their local contact number, with a copy marked to their respective directorates.

2. The payment against the submitted bills (which are submitted in full and complete shape) will be processed and paid through DD or Cheque drawn in favour of M/s. Ramky Energy & Environment Ltd payable at Madurai within 21 working days from the date of submission. List of Government Hospitals Annexure is attached for your notice.
