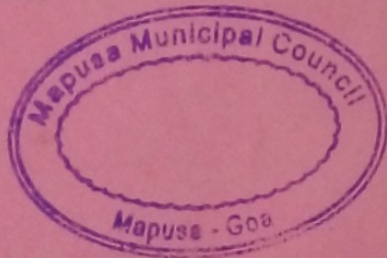

*If any nuisance or any litigation arises after issue of trade licence, the Council reserves the right to revoked/cancel the trade licence.

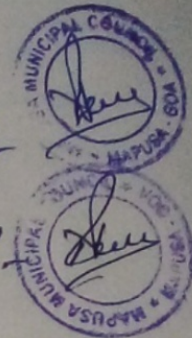
Note: 1. Duplicate licence can be obtained if the original licence is lost/mutilated/details added or deleted.
