Karnataka State AIDS Prevention Society (KSAPS) was formed in 1997 and functioning as a society under the National AIDS Control Organization (NACO) which is a division of the Ministry of Health and Family Welfare of the Central Government of India. The programs of KSAPS are governed by the guidelines of National AIDS Control Program (NACP).

In Karnataka there are 445 (435 + 12 PPP) Stand Alone Integrated and Counseling Centers (SA-ICTCs) that offer counseling and testing services in Medical Colleges, Head Quarters Hospitals, Govt Primary Health Centers etc.

Memorandum of Understanding

This Memorandum of Understanding is made on this 01st July -2023

BETWEEN

M/s. Prajwal BMW Management Systems (A Unit of V V Incin Solutions Pvt Ltd) is having its Plant office at Plot No.1-B-9 Near HPCL, H N Pura Road, Hassan Growth Center, KIADB, Hassan-573201. Hereafter refer to as **CONTRACTOR. (CBMWTF)**


AND

M/s. Community Health Centre, Birur Kadur (T) Chikmagalore-(Dist), here in after refer as **Community Health Centre.**

- a. **CONTRACTOR. (CBMWTF)** has consent and Authorization with Pollution Control Board having a common treatment facility for managing Bio-Medical waste in Hassan district at Plot No.1-B9 Near HPCL, Hassan Growth Center, KIADB, Hassan-573201. The facility is having state of Autoclave system along with shredder and Incinerator.
- b. **Community Health Centre** gives its bio-medical waste properly packed in color coded bags (in case of amputated parts the hospital should give one letter duly signed by authorized person mentioning the patient's name, age & reason for amputation) as per pollution control board regulations for treatment and final disposal to Plot No.1-B9 Near HPCL, Hassan Growth Center, KIADB, Hassan-573201. The waste should be given at one single point by the **Community Health Centre** at given time of **CONTRACTOR. (CBMWTF)**
- c. **Community Health Centre** has **30 (Thirty only)** beds. The exact number of beds will be taken from the declaration given by the state authorities or Physical beds **CONTRACTOR. (CBMWTF)** will charge a price of **Rs.7/-(Rs. Seven Only)** per bed Per day as agreed for collection, transportation, treatment and final disposal of bio-medical waste.
- d. **Community Health Centre** is assuring that the payment should be made through Account payee cheque in favor of M/s. V V Incin Solutions Pvt Ltd On or before 7th of every month. In case of non-receipt of payment on the agreed date from **Community Health Centre** on the next working day payment should be made, If not paid for a period of one week **CONTRACTOR. (CBMWTF)** will stop the collection of waste with intimation to Karnataka State Pollution Control Board
- e. **CONTRACTOR. (CBMWTF)** will collect properly Segregated Bio-medical waste regularly and treat the waste as per the regulations. **CONTRACTOR. (CBMWTF)** will not collect any waste that is not segregated or properly packed and also general garbage Like Food waste, papers, cartoon boxes And Plastics rappers Etc... Any usable materials (surgical instruments, Lab equipments, etc.) received along with the Bio-medical waste from your HCE'S, **CONTRACTOR. (CBMWTF)** will not responsible.

- f. **Community Health Centre** if requested will supply the color coded waste collection bags at a nominal rate mutually decided between **CONTRACTOR. (CBMWTF)** and hospitals.
- g. **CONTRACTOR. (CBMWTF)** will issue a proof of Bio-Medical Waste collection from **Community Health Centre** as per norms. This will help the individual hospital for getting compliance with the state pollution control board. The individual hospital/Nursing home can take their authorization from the pollution control board by informing the board that M/s. Prajwal BMW Management Systems (A Unit of V V Incin Solutions Pvt Ltd) treats their waste, (The same has to be mentioned in the authorization form-1).
- h. In case of hospital/Nursing home/clinics find any irregularities in collection waste, they can send a notice in writing to **CONTRACTOR. (CBMWTF)** for immediate action.
- i. In case of collection of waste by next day under prior intimation or valid reason, the **Community Health Centre** may waive such penalty to the Company for that particular day.
- j. **CONTRACTOR. (CBMWTF)** will maintain their plant in good condition all the time and ensure continuity of service on all the days without fail and get clearance from the Pollution Control Board as per regulations.
- k. This Memorandum of understanding is entered into on the express understanding that **CONTRACTOR. (CBMWTF)** will maintain and run the facilities and collect transport and treat the waste at their plant strictly in accordance with the consent of the Karnataka State Pollution Control Board and it shall be the responsibility to obtain the consent and keep the same always in force.
- l. In case of violation of any of the agreed conditions of the MOU by either side, Issue of notice may terminate this MOU three months in advance by either party for terminating their respective obligations.
- m. This Memorandum of Understanding will remain valid for a period of one year three month commencing from 1st July -2023 to 30th June -2024, after which date the agreement will automatically stand terminated by the efflux of time unless extended further by mutual agreement. All disputes to this understanding are subject to the jurisdiction of the court in Hassan.

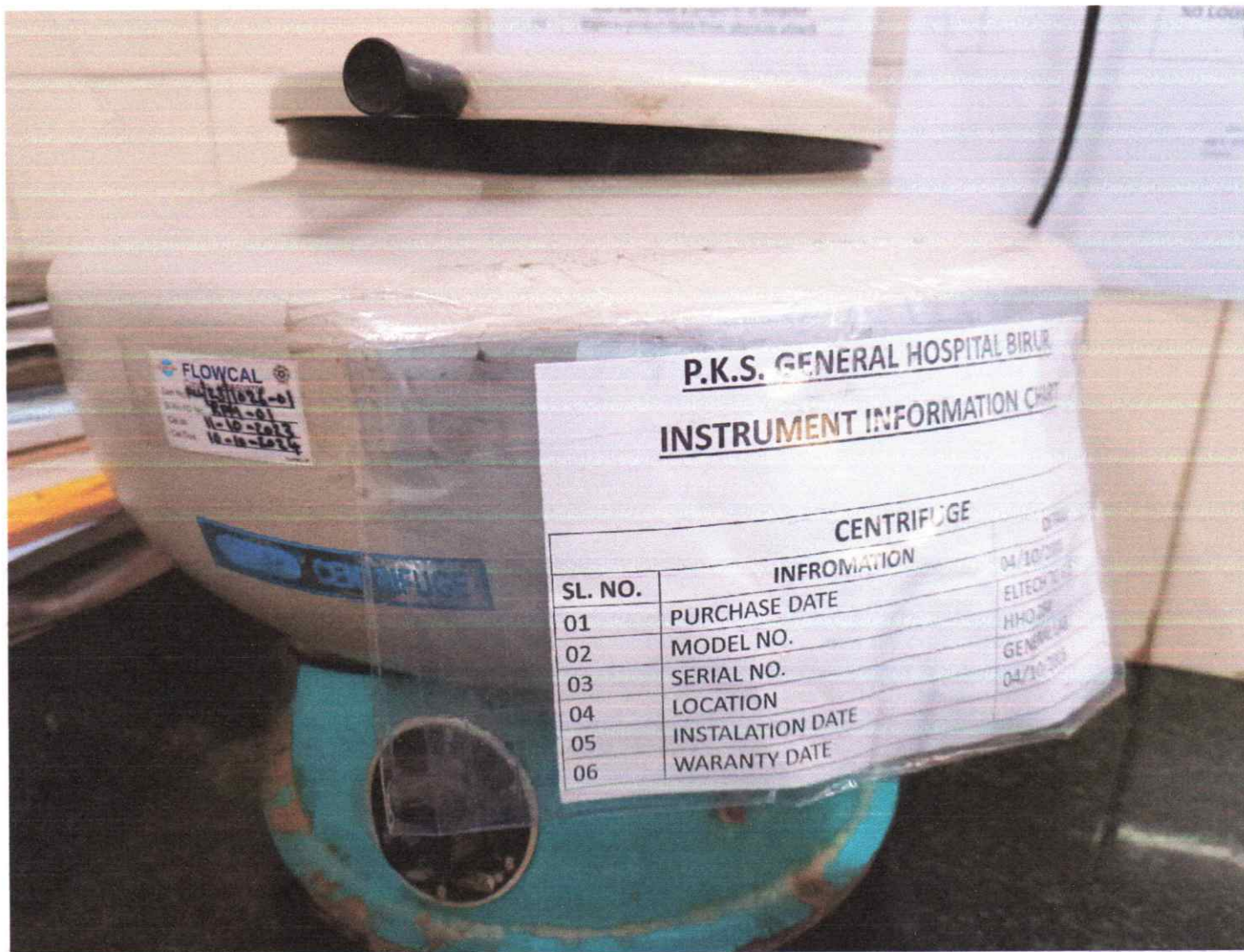
