(iii) The admission process for the academic year 2013-14 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended. No admission is permitted beyond the cut-off date.

It shall be incumbent upon the Medical College that the information relating to admissions should be submitted within a fortnight of closure of admissions to the Council. Any failure to submit the information within this time limit would be construed that the admissions in the College were not in accordance with the statutory requirements, thereby enabling the Council to proceed in accordance with law against the College.

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the assessment report (5th & 6th March, 2018) with regard to recognition/approval of ESIC Medical College, Chennai, Tamilnadu for the award of MBBS degree (100 seats) granted by The Tamilnadu Dr. M G R Medical University Chennai u/s 11(2) of the IMC Act, 1956 was carried out by the Council Assessors on 29th August, 2018. The assessment report (29th August, 2018) along with previous assessment report (5th & 6th March, 2018) was considered by the Board of Governors at its meeting held on 11/11/2018 and decided to recommend to the Central Government for recognition/approval of ESIC Medical College, Chennai, Tamilnadu for the award of MBBS degree (100 seats) granted by The Tamilnadu Dr. M G R Medical University Chennai u/s 11(2) of the IMC Act, 1956.

The Board of Governors further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."
