In Karnataka there are 445 (435 + 12 PPP) Stand Alone Integrated and Counseling Centers (SA-ICTCs) that offer counseling and testing services in Medical Colleges, Head Quarters Hospitals, Govt Primary Health Centers etc.

As per NACO guidelines, to maintain and enhance quality of SA-ICTCs through the implementation of Quality Management System (QMS) followed by NABL Entry level Certification. In this regard, the following SA- ICTCs initiated the process of applying NABL M(EL)T certification.
