

- 6. That the capital of the Partnership shall be Rs.2,00,000/(Rupees two lacs only) which shall be contributed by the First partner only.








- 8. That the second partner shall provide a separate toilet at the ground floor and also the second partner shall provide a separate meter for using electricity.

- 15. That if any of the partner is not willing to continue to remain partner. She/he shall be at liberty to retire from the partnership firm but she/he shall have no right to dissolve the partnership firm. He/she shall not be entitled to disturb the running of the partnership business.
