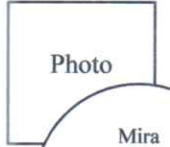

- 4) The licensee shall be required to submit requisite certificate from the Maharashtra Pollution Control Corporation wherever such certificate shall be deemed necessary.
- 5) No alterations or modifications can may be made to the licensed business, business name, or the registered address or location without obtaining prior permission from the Municipal Corporation.
- 6) The licensee shall be responsible for obtaining all necessary permissions from various departments within the Municipal Corporation and relevant government authorities.
- 7) In the event that any documents submitted for the acquisition of this license are subsequently discovered to be false or forged, the licensee shall bear full responsibility for the authenticity of said documents.
- 8) The licensee is strictly prohibited from employing child labor at business premises.
- 9) In the event of a dispute or complaint arising in connection with this license, the decision of the Hon. Commissioner shall be considered final. Furthermore, any violation of the terms and conditions upon which this license has been granted may result in its suspension or Cancellation.
- 10) This license must be conspicuously displayed at the licensed place of work/business.
- 11) If, due to unavoidable circumstances, there is a necessity to employ another person for a brief duration at the licensed premises, the licensee is required to submit written notice to the Medical Health Officer at least two days in advance, along with the eligibility certificate of that person.
- 12) The licensee is obligated to promptly notify the medical department of the presence of infectious and epidemic patients, such as winter fever, dengue, leptospirosis, chikungunya, swine flu, tuberculosis, leprosy, etc.
- 13) It is mandatory for the licensee to submit information of all beneficiaries (children and pregnant women), who have been vaccinated to the concerned medical officer in the prescribed format on a monthly basis.
- 14) The Municipal Corporation retains the power to amend aforementioned terms and conditions at any time.
