a) The objects to be pursued by the company on its incorporation are

To purchase, construct, develop, own, lease or otherwise acquire, establish, maintain, operate, run, manage or administer hospitals, healthcare home centers, medicare, healthcare, nursing homes, diagnostic, health aids, Intensive Care Units(ICU) at home, clinics, medicine shops, and research centers.

To provide integrated healthcare delivery services includes primary care, secondary care, home and community care in all the fields of medical and healthcare services at large.

To deal in machineries and equipment used and related to health care facilities and services.

To render services, consultancy and assist in setting up hospitals, healthcare centers, home centers, and manufacturing medical equipment, etc.

To provide service and consultancy related to preventative health care, laboratory and diagnostic care, physical and occupational therapy, pharmaceutical care for the treatment, recovery, or cure of disease.

To impart medical and healthcare education and management training to the healthcare staff including primary care providers, paramedical staff, ward boys, nurses, specialists, pharmacists, medical staff, laboratory technicians, trainees, etc.

To establish, own, run, promote, lease, and manage educational institutions, schools, colleges, medical institutes for imparting medical and healthcare education and management training including Health and Hospital Management Training and Development, Pharmaceutical Management, Hospitality, Programs for skills and competency development, Training and certification of professionals, etc.

b) Matters which are necessary for furtherance of the objects specified in clause 3(a) are

To hold exhibitions, seminars, meetings, lectures, and classes and to publish or distribute newspapers, magazines, books, and other literary works in connection with the activities and in furtherance of the objects of the Company.

To undertake to provide suitable hotel and home accommodation primarily for patients and their friends and relatives and to undertake all or any of the business activities incidental thereto.

To purchase, charter, hire, build or otherwise acquire vehicles of any or every sort of description for use on or under land or water on the air and to employ the same in the carriage of merchandise of all kinds of passengers and to carry on the business of owners of trucks, trams, lorries, motor cars and of ship owners and lighter-man and owner of the aircraft in all or any of their respective branches.

To provide, encourage, initiate, or promote facilities for the discovery, improvement, or development of new methods of diagnosis, understanding, and prevention and treatment of diseases.

5. To conduct and to carry on experiments and to provide funds for research works and for scholarships, stipend, remuneration and/or other payments or aid to any person or persons encouraged in research work, or work connected with or conducive to research and to encourage and to improve knowledge of the persons who are engaged or likely to be engaged in any medical or related profession so as to make available medical relief to the public at large.
6. To promote manage, cooperate with or afford assistance to or otherwise assist the work of any other foundation, institution, or body engaged in medical research, treatment.
7. To establish, maintain and/or manage hostel, building houses, staff quarters, and other conveniences for the benefit of the students, staff, and other employees of the Company.
8. To purchase, take on lease, or in exchange, hire or otherwise acquire any estates, land or lands, in India, or elsewhere, and any rights, privileges, and easements and concessions and factories machinery, implements, tools, live and dead stock, stores effects, and other property, real or personal, immovable or movable of any kind which may be required for attaining the main objects.
9. To buy or generate for its own use or otherwise steam, heat, light, electricity, gas, motive power, and hydro-electric or water power for the purpose of the business of the Company.
10. To construct, maintain and alter any buildings, or works, necessary or convenient for the purposes of this company and to purchase, hire, construct, improve, maintain, work, manage, carry out, or control any roads, branches of sidings, bridges, reservoirs, watercourses, river transport services, wharves, manufactories, warehouses, electric workshops, stores, jetties, and other conveniences and works which may seem calculated directly or indirectly to advance the company's interest and to contribute to subsidize or otherwise assist or take part in the construction, improvements, maintenance, workings, management, carrying out, or control thereof.
11. To acquire from any Sovereign or state authorities in India or elsewhere, any concessions, grants, decrees, rights, powers, and privileges whatsoever, which may seem to the Company capable of being turned to account and to work, develop, carry out, exercise and turn to account the same.
12. To plant, grow, and produce agricultural products and other products of any kind in India or elsewhere necessary or useful for the business of the company.
13. Generally to undertake and carry on any business, transactions or operation commonly undertaken or carried on by explorers, prospectors, or concessionaires and to carry on any other business which may seem to the company capable of being conveniently carried on in connection with any of the objects of the company, or which may be thought calculated directly or indirectly to enhance the value of or render profitable, any of the company's property or rights.
14. To enter into any arrangements or agreement with any Government, State or authority, municipal, local or otherwise, or any corporation, companies, or persons that may seem conducive to the attainment of the company's objects or any of them and to obtain from any such Government, State authority, Co-operation, Company or persons any rights, privileges or concessions and to carry out, exercise and comply with such arrangement or agreement.
15. 17. 18. 19. To form, promote, subsidize, organize, and assist or aid in forming, promoting, subsidizing, organizing or aiding companies, syndicates or partnerships of all kinds for the purpose of acquiring and undertaking any property and liabilities of the Company or of advancing directly or indirectly the object thereof and to take or otherwise acquire and to hold shares in any other company having objects similar to those of this Company.
20. To draw, make, accept, endorse, execute, issue, and negotiate bills of exchange, promissory notes, cheques, drafts, hundies and other instruments of every description.
21. To issue money on deposit, at interest or otherwise and to lend and advance money with or without security to such persons and companies and on such terms as may seem expedient. However, the Company shall not do the business of banking as defined in the Banking Companies Regulation Act, 1949.
22. Subject to the provisions of the Act, to receive money on deposit, at interest or otherwise and to lend and advance money with or

without security to such persons and companies and on such terms as may seem expedient. However, the Company shall not do the business of banking as defined in the Banking Companies Regulation Act, 1949 and subject to section 73 of the Companies Act, 2013, and the rules thereunder.

23. To layout, advance, invest and deal with the Company's money to such person or company and in or upon such investments or securities and generally in such manner as may from time to time be determined.
24. To procure the Company to be registered, incorporated, or recognized in any place outside India.
25. To give donations or subscriptions to any religious, charitable, or social institutions or to give any charity incidental to or conducive to any business that may be carried on by the Company.
26. To distribute any of the properties of the Company among the members in specie or otherwise, but so that no distribution amounting to a reduction in the capital be made without the sanction (if any) for the time being required by the law.
27. To pay for any property or rights acquired by the Company either in cash or fully or partly paid shares with or without preferred or deferred rights in respect of dividends or repayment of capital or otherwise or by any securities which the Company has power to issue or partly in one mode and partly in another and generally on such terms as the Company may determine.
28. To take part in the management, supervision, or control of the business or operation of any company or undertaking and for that purpose to appoint and remunerate directors, accountants, or other experts or officers, but not act as Manager or Managing Agent of any other Company.
29. To sell, exchange, mortgage (with or without the power of sale) assign, lease, sublet and generally otherwise deal with the whole or any part of the business, estate property or undertaking of the Company, as a going concern, to any person or persons, association or associations, or otherwise for such consideration as the company may think fit, either for cash or for shares, debentures, or securities for any other company having objects altogether or in part, similar to the objects of this company and to hold or distribute among the members in specie or otherwise the whole or part of the consideration for such sale or amalgamation with any person, company or association.
30. To establish or aid in the establishment of associations, institutions, funds, trusts, and charities and other conveniences intended to benefit employees or ex-employees of the company or their dependents and to grant pension or allowances and generally to subscribe money for any public general or useful objects.
31. To pay all or any expenses incurred in connection with the promotion, formation, and incorporation of the Company or to contract with any person, firm or company to pay the same and to pay commission to brokers and others for underwriting, placing, selling or guaranteeing the subscription of any shares, debentures, debenture stock or securities of this company.
32. To insure with any person, firm, association or Company against losses, damages, risks and liabilities of any kind which may affect the Company either wholly or partially and if thought fit, to effect any such insurance by joining or becoming a member of any mutual insurance, protection or indemnity association, federation or society and to accept any such insurance or any part thereof for the account of the Company.
33. To enter into all contracts with persons in India or outside for the purchase or sale of all goods, materials, commodities, metals, minerals, jewels, stores, provisions and produce of all kinds, both raw and manufactured, for the business of the Company and to make advances to persons in India or outside in respect of such contracts for the development of the business of the Company.
34. To establish and construct buildings and houses required to accommodate officers and workmen as may be found necessary.
35. To subscribe for, conditionally or unconditionally or absolutely, purchase, hold, underwrite, negotiate, and deal in loans, stocks, shares, bonds, or obligations of any Government, State or Central, local authority, port trust, municipal body, or any company or other corporation and the shares, stock, debentures and debenture stock (whether perpetual or terminable) of any Joint Stock company or Co-partnership and investments of all kinds.
36. To purchase or otherwise acquire, undertake and carry on the whole or any part of the business, goodwill, property, assets, and liabilities of any person or persons, firm or company carrying on any business of any nature altogether or in part similar to any business which the Company is authorized to carry on or possessed of property suitable for the purses of the Company and to pay for the same and all other properties or rights of whatever kind acquired by the company in cash or in shares, debentures, debenture-stocks of the company to carry on, pending a sale of realization, any business which the Company may as mortgage have taken possession of or acquired.
37. To amalgamate, enter into partnership or any arrangement whether terminable or otherwise, for sharing profits, union of interest, joint adventure, reciprocal concessions, co-operation, or otherwise, with any person or persons, firm, association, company or corporation, having objects altogether or in part similar to those of the Company or carrying on or about to carry on or engaged in or about to engage in any business or transaction which the Company is authorised to carry on and to lend money and to guarantee the contracts and to subsidise or otherwise assist any such persons, persons, firm, association, corporation or company; to subscribe for and to take and otherwise acquire and to hold shares or other interest or stock or securities, of any such person, persons, firm, association, corporation or company and to sell, hold re-issue with or without guarantee or otherwise deal same and accept other shares in exchange for the same; and to form, constitute or permit any other company or companies for the purpose of acquiring all or any of the properties, rights and liabilities of this Company.
38. To join and participate in any Chamber of Commerce or Commercial institutions or Bodies as member or associate member and pay all subscriptions and other amounts for such purpose.
39. To employ experts to investigate and examine the conditions, prospects, value, character, and circumstances of any business concerns and undertakings and generally of any assets, property, or rights.

40. To establish, promote, form and subsidize or otherwise assist in establishing, promoting, forming and subsidizing any other Company and to prosecute or assist in the prosecution of any other undertaking or enterprises of any description and to secure by underwriting or otherwise in subscription of all or any part of the share, loan or other capital, including any stock, shares, debentures, debenture stock or other securities of this Company or any other Company and to pay and to receive any commission, brokerage or other remuneration in connection therewith and to obtain a settlement of quotation upon any exchange or any share loan or other capital of this Company or any other Company.
41. 42. To assist any Company, financially or otherwise by issuing or by subscribing for or guaranteeing the subscription and issue of capital, shares, stock, debentures, debenture-stock or other securities and to take, hold and deal in shares, stock and securities of any Company notwithstanding any liability that may be thereon.
43. To acquire and hold shares in any other Company and pay for properties, rights or privileges, acquired by this Company, either in shares of this Company or partly in cash or otherwise and to give shares or stock of this Company in exchange for shares or stock of any other Company, provided that the investments are made out of surplus funds.
44. To float and bring into existence such companies as may appear advantageous and to conduct the business of such companies as their Agents.
45. To undertake and carry on any business transaction or operation commonly undertaken or carried on by financiers, promoters of companies, bankers, underwriters, concessionaires and contractors for, public and other works, capitalist or merchants, in particular, to underwrite issue and place shares, stocks, bonds, debenture-stocks, and securities.
46. To effect insurances and assurances on the lives of any debtors to the Company or on the lives of any other persons in whom the Company may have an assurable interest and to pay the premiums and other sums of money required to keep up the policies of assurances out of the money of the Company.

50. To apply the assets of the Company in any way in or towards the establishment, maintenance or extension of any association, institution or fund in any way connected with any particular trade or business or with trade or commerce generally including any association, institution or fund for the protection of the interests of masters, owners and employees against loss by bad debts, strikes, combinations, fire, accident or otherwise or for the benefit of any clerks, workman or other at any time employed by the Company or other families or dependents and whether or not in common with other persons or classes of persons and in particular of friendly, cooperative and other societies, reading rooms, libraries, educational and charitable institutions, refractories, dining and recreation rooms, places of workshop, schools, and hospitals and to grant gratuities, pensions, and allowances and to contribute to any funds raised by public or local

subscriptions for any purpose whatsoever.

56. To establish and support or aid in the establishment and support of associations, institutions, funds, trusts, and conveniences calculated to benefit the person who are or have been Directors or who are or have been employed by or who are serving or have served the Company or any Company which is a subsidiary of the Company or the dependents or connections of such persons and to grant pensions and allowances and to make a payment towards insurance.

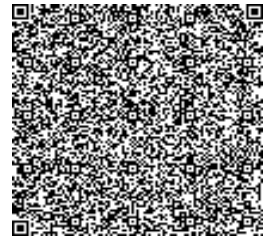
