Generation

2. This authorisation is subject to the conditions as per Annexure I and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act, 1986.

Other Conditions

1. This is a one-time authorization which need not be renewed or taken afresh unless got cancelled.
2. Annual report in Form IV as per the Bio Medical Waste Management Rules, 2016 shall be submitted on or before 30th June every year failing which the authorization will get automatically cancelled.
3. Bio Medical Waste shall not be mixed with other waste. Bio Medical Waste shall be segregated into containers, bags at the point of generation in accordance with Schedule- IV, of the rules.
4. Liquid waste shall be subjected to proper disinfection before discharge.
5. The authorized person shall ensure the collection & transportation of Bio Medical Waste in vehicles specifically designed for the purpose in a safe and hygienic manner as per Central Pollution Control Board guidelines-2003.
6. The authorized person shall maintain record related to the generation, collection, reception, storage, transportation, treatment, disposal and /or any form of handling of Bio Medical Waste.
7. The prescribed authority may cancel or suspend an authorization at any point of time, if for reason, to be recorded in writing the occupier/operator has failed to comply with any provision of the act or rule there in.
