- 3. Payment of Electricity Bills and fixation of rates
  As per the Concession Agreement, Authority to provide electricity and water
  connection to project site and payment of bills in this regard may be done by
  Krsnaa Diagnostic Ltd. from when the centre would be operationalized.
  - KDL vide their letter no KDPL/PPP/Patho/Punjab/Gen/2020-21/58 dated 07.12.2023 informed that it was decided that old electricity bills shall be paid by 15.10.2023. Given the circumstances, KDL requested the authority for an extension of the timeline to effectively gather and submit the necessary data related to electricity charges for the centres situated in Punjab. This additional time is essential to ensure accurate and comprehensive reporting of the electricity usage and charges for each centre. Further, they have paid an amount of INR 2,64,01,814 (Two Crore Sixty Four Lakhs One Thousand Eight Hundred Fourteen Rupees Only) for the electricity consumption. Also, a provisional and unverified outstanding electricity payments that amounts to INR 1,23,79,504 (One Crore Twenty-Three Lakhs Seventy-Nine Thousand Five Hundred Four Rupees Only) is enclosed as Annexure C and also
  - Further, KDL propose that a total of INR 1,18,66005 (One Crore Eighteen Lakhs Sixty-Six Thousand Five Rupees Only) which is the outstanding payment for the services rendered under the Aam Aadmi Clinics. However, the said outstanding payment was not released. Therefore, KDL would request the authority to adjust the electricity charges with the outstanding payments for Aam Aadmi Clinics.
  - As per performa, enclosed with letter no PHSC/PROJ/2023/1543 dated 10.08.2023 (Annexure D) regarding electricity usage issued to KDL, KDL may asked to submit the bills copies from SMO/DMC.
  - PHSC needs to issue letter to DMC /SMO instructed them to take a note from KDL regarding Electricity usage and reconciliation accordingly.
