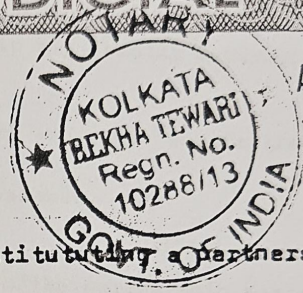

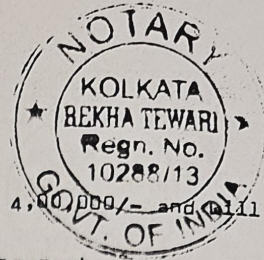

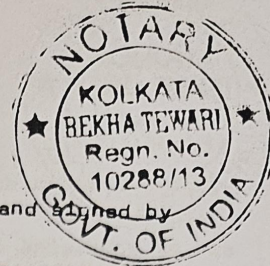

and balance sheet for the year will be prepared and signed by both the parties and each partner will be get one copy of such profit and loss account and balance sheet.

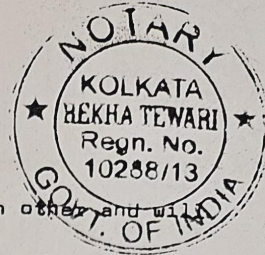

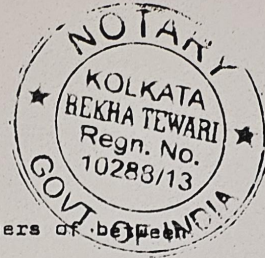
