- 1. SONARPUR., KOI .KATA-700103. however the partners upon their consensus of opinion may change the head office or any other place for activity of the firm to some other place or places.
- 4. NATURE OF BUSINESS: The business of the PARTNERSHIP shall be that of health—care, diagnostic centre as well as other health and health diagnosis related business and the parties shall always be entitle to embark upon any other line of trade or business as they agree upon from time to time.
- 5. COMMENCEMENT & DURATION: The PARTNERSHIP business shall commence on and from Sixteenth day of September Two Thousand Thirteen and it will be treated as partnership -at-will. The partnership firm may be dissolved at any time with the mutual consent of both the parties hereto.
- 6. CAPITAL: the initially total capital of the Partnership Business is Rs.4,00,000/-(Rupees Four Lac) only, each partner investing Rs.2,00,000/- (Rupees TwoLakh) only. The capital of the partnership firm shall be contributed by both the partners in equal proportions.
