CONDITION OF REGISTRATION

5. The certificate of registration shall be displayed in prominent place in a part of the premises open to the public and inspecting authority.
6. The Registration Certificate Holder shall be comply with the provision of the Orissa Clinical establishment (Control and Registration) Act. 1990 and Rules made there under for time being in force.
7. The Certificate Holder shall report to the Supervising Authority any change in technical staff within one month of such change.
8. No drugs shall be used in the establishment unless purchased with authorised bill from a licensed manufacturer and seller and should be handled only by registered Pharmacist in compliance with provision of Section - 42 of the Pharmacy Act. 1948.
9. The Certificate Holder shall inform the Supervising authority in writing in the event of any change in the constitution of the management of the establishment where any change in the constitution of the Management of the Establishment takes place. The current certificate so issued shall be valid for period of three months from the date of the change unless, in the meantime, fresh certificate has been obtained from the approving authority. in the name of the new establishment with the changed constitution.
