



Sir,

With reference to the above subject and reference letter, it is understood that the Employees' State Insurance Corporation Hospital, Bibvewadi Pune is a government hospital and therefore a certificate from our office is required stating that a specific registration number is not required for it.

Section 18 (1) of the Maharashtra Nursing Home Registration Act 1949 states that this Act shall not apply to any nursing home run by the government or a local authority or by a group of persons authorised by the State Government for this purpose.

Since the Employees' State Insurance Corporation Hospital, Bibvewadi Pune is a government hospital, it appears that the said hospital does not require registration under the said Act. Therefore, this matter is being submitted for your information.

It is to declare that ESIC Hospital, Bibvewadi is a government hospital operating under the control of Employees' State Insurance Corporation, New Delhi. ESI Corporation is a statutory organisation functioning under the control and supervision of Ministry of labour & Employment, Government of India. The hospital is dedicated to provide medical benefits to individuals insured under the provisions made under ESI Act, as well as their dependents.

Clinical Establishments (Registration & Regulation) Act, 2010 states that those categories of Clinical Establishment exempted by the state Government are outside the purview of this Act.

The jurisdiction of Maharashtra nursing Homes Registration Act, 1949 extends to province of Bombay which includes city of Poona. As envisaged under section 18 of the Maharashtra Nursing Homes Registration Act, any nursing home carried on by Government or a local authority or by any other body of persons approved by the [State] Government in this behalf is exempt from the requirement of registration under the said Act. In accordance with the provisions of the said Act, ESIC Hospital, Bibvewadi Pune is not required to get itself registered under Maharashtra Nursing Homes Registration Act.
