NOW THIS DEED OF PARTNERSHIP WITNESSETH AND THE PARTIES HERETO HEREBY AGREED AS FOLLOWS:

1. That the partners hereto shall carry on business of pathological laboratory and diagnostics and all related business under the name and style of "**ASSURE SPECIALITY LABORATORY**" with its principal place of business at Ground Floor of the premises No. 714/2, Sahid Hemanta Kumar Bose Sarani, Jawpur, Near Milan Chakra Club, Motijheel S.O., Kolkata - 700074 or at such other place or places as the partners mutually decided from time to time.

2. That all the partners hereto would invest Rs.3,00,000/- (Rupees Three Lacs) each, totaling to Rs.9,00,000/- (Rupees Nine Lacs) only for set-up of the aforesaid business.

3. The profit and loss of the partners shall be distributed between the partners as follows :

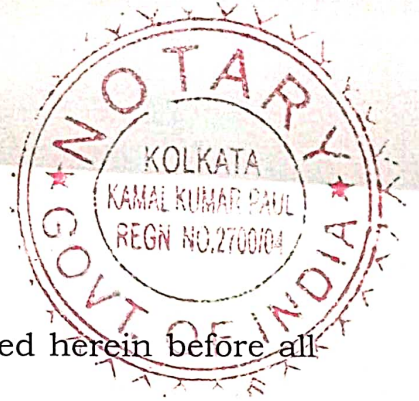
First Partner	:	33.3% Loss/Profit
