03. That the capital of the firm has been supplied by all the partners as per books of account. It is expressly stated that dissimilar contribution of the capital by the partners shall not in any way affect other interests of the partners as per these presents. That the respective shares of the aforesaid three partners of the firm in the profits and or Losses (if any) of the firm in the assets as well as the liabilities thereof shall be as follows :

That each of the partners shall at all reasonable hours of day and night be entitled to freely inspect, examine and / or take copies of all accounts, documents, records, papers etc. relating to this partnership either personally or through some agents authorised in writing in this behalf.

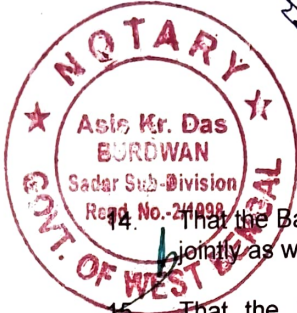

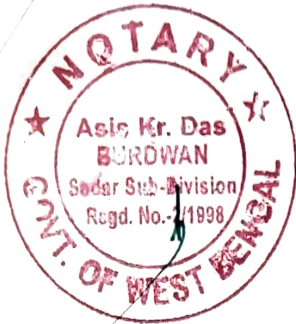
14. That the Bank account can be operated by any one of the above named Partners jointly as well as severally.
15. That the incoming partners Smt. Basanti Rani Jash & Smt. Rumna jash specifically agreed to take the liability of Term Loan of the firm standing with the State Bank of India, Bhatar Branch.
16. That notwithstanding any contrary provisions contained in these presents, it shall be open to the above named partners in the event of unanimity amongst themselves :
 - a) to alter, postpone, cancel or modify any of the provisions set forth herein.
 - b) to close or open branches or new business either by themselves or in partnership with other individuals, to admit any new partner or partners to this firm and settle terms and conditions thereof.
17. That in the event of the death of any of the aforesaid partners the firm will not be dissolved but the deceased partner's legal heirs and successors will step into his place and the firm shall carry on.
18. That all disputes and differences amongst the partners shall be settled by arbitration. The Board of Arbitrators shall consist of one person nominated by each of the partners.
19. That all the partners shall be entitled to get maximum simple interest on credit balance lying to their respective account as per provision of Sec. 40(b)(iv) of the I. T. Act or any other applicable provisions as may be in force in Income Tax Assessment of the Partnership for the relevant accounting period. The said interest shall be computed on the balance to the credit of the account during the last day of each calendar month and such interest shall be paid by crediting their respective personal accounts at the end of the year. Be it provided further that such rate of interest can be taken at lower rate or such term may be altered / varied by the consent in writing of all the partners without executing any fresh deed of partnership and such variation / alteration / change shall be binding amongst the partners.
